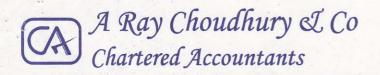

The "HELPLINE HEALTH CARE SOCIETY" is a Voluntary Non-Govt. Organization of Assam was Registered on 29th December, 2004 under Society Registration Act XXI 0f 1860, Vide Registration No.- RS/KAM/240/V/654 of 2004-05

As the Society is a Voluntary Organization, it has been working since its inception i.e. 2004 in the field of all around Development aspect according to the Chief aim and objective for the purpose of which the Society initially constituted.

VISION:-

MISSION:-
